

BELLS BOARD MEETING  
MARCH 12, 2018

Aldermen present: Bob Pigue, Scotty Runions, Lee Overton, Dabney Long and Eric Jordan. Mayor Joe Williams, presided. Alicia Pigue, Recorder.

Others present: Chief Jenkins, Junior Jordan, Robert Reynolds, Ed Jackson III, Katie Taylor, Alma Sherrod and Jordan McKenzie.

Mayor Williams called the meeting to order and Alderman Eric Jordan gave invocation.

Robert Reynolds discussed the potential for a new subdivision in the Porter Place area.

Ed Jackson, Regional Director for Congressman Kustoff introduced himself.

Alderman Scotty Runions moved to accept the minutes of the previous meeting as written. Alderman Eric Jordan seconded the motion. All Aldermen voted, Aye. Motion carried.

Mayor Williams presented financial statements for February and year to date.

Mayor Williams presented Ordinance No 042018 **“AN ORDINANCE OF THE CITY OF BELLS, TENNESSEE, ESTABLISHING A FEE SCHEDULE FOR CUSTOMERS OF SOLID WASTE COLLECTION SYSTEM”** Alderman Scotty Runions moved to adopt the ordinance on its first reading and same be made apart of the minutes of this meeting. Alderman Dabney Long seconded the motion. Thereupon Mayor Williams called for a roll call vote with all Aldermen present and All Aldermen voting Aye. Motion carried.

Chief Jenkins reported that he is still searching for full time and part time certified officers.

Alderman Scotty Runions moved to adopt the Standard Subdivision Development Contract that Mr. Reynolds had presented upon approval from City Attorney Jasper Taylor. Alderman Lee Overton seconded the motion. Thereupon Mayor Williams

called for a roll call vote with the following results: Alderman Bob Pigue, Aye; Alderman Scotty Runions, Aye; Alderman Lee Overton, Aye; Alderman Dabney Long, Aye; Alderman Eric Jordan, Nay. The Ayes having the vote Mayor Williams declared the motion carried.

Alderman Bob Pigue moved to request that County Mayor Gary Reasons petition County Wide Utility District to exempt the new subdivision off of Porter Place from the County Wide service area, therefore releasing the City from the \$12 per household regulation for the new customers. Alderman Eric Jordan seconded the motion. Thereupon Mayor Williams called for a roll call vote with all Aldermen present and all Aldermen voting, Aye. Motion carried.

Mayor Williams presented the delinquent taxes for the year 2016 to be turned over to City Attorney Jasper Taylor for collections. Alderman Eric Jordan moved to turn over the taxes as presented. Alderman Dabney Long seconded the motion. All Aldermen voted, Aye. Motion carried.

City Recorder Alicia Pigue announced that the next Utility Board Training would be on April 10, 2018 at Jackson Energy Authority.

Being no further business Alderman Eric Jordan moved the meeting adjourn. Alderman Dabney Long seconded the motion. All Aldermen voted, Aye. Motion carried.
