Thereupon Mayor Williams called for a roll call vote with All (5) Aldermen present and All (5) Aldermen voting “Aye”. Motion carried.

The Mayor and Board of Aldermen discussed property lines of the Nutrition site and getting an estimate of taking off the carport and installing a driveway and parking and making parking handicap accessible.

Josh Work with Pictsweet Company presented a cost model Proposal using 2/3 of the Fye 2016 projected year end usage. Alderman Bob Pigue moved to accept the proposal as presented by Mr. Josh Work. Alderman Eric Jordan seconded the motion. Thereupon Mayor Williams called for a roll call vote with the following results: Alderman Bob Pigue, “Aye”; Alderman Scotty Runions, “Nay”; Alderman John Pigue, “Aye”; Alderman Dabney Long, “Pass”; Alderman Eric Jordan, “Aye”. The Ayes having the vote, Mayor Williams declared the motion carried.
